

USING 2020 BASELINE:

At Vericast, we're stewards of the planet, dedicated to making a positive impact through sustainable decisions.

CONTINUOUS IMPROVEMENT & LEED CERTIFICATION

LEV Parking Preference:

- Assigned parking at Vericast's San Antonio campus encourages lowemission vehicles (LEVs).
- Preferred parking acknowledges and promotes employee commitment to emission reduction.

Remote Work Policy:

- Flexible work schedules since 2021 reduced travel to the office.
- 28% of Vericast employees are now remote, cutting emissions and reducing employee costs.

Emissions Reduction Success:

- 2020 Baseline: 10,325.14 metric tons CO2 reduced from 2020 to 2021.
- 63% reduction in employee emissions due to LEED, consolidation, and remote work.
- Additional 37% reduction in 2022 (3,698.8 kg CO2e).



GOVERNANCE & STAKEHOLDER ENGAGEMENT:

2023 Continuous Improvement Actions:

- Consolidating manufacturing reduced electricity consumption by 6,700 MWh.
- Scopes 1+2 emissions down by 44.52% vs. 2018 baseline.
- Enhanced machine efficiency and energy-saving initiatives.
- Management software implementation cut 3,071,400 kWh over 2 years at one site.

Impact of Digital Transition:

- Reduced paper use = fewer environmental impacts (biodiversity, carbon sequestration).
- Virtual meetings, remote work, and sustainable supply chains (FSC-certified paper).

Climate Strategies & EMS (Environmental Management System):

- 100% carbon-neutral shipping by 2040.
- EMS aligns with ISO 14001:2015 and Vericast's sustainability goals.
- Advanced recycling capabilities save 70M+ lbs annually, reducing GHG emissions by 4,253 MTCO2e since 2017.

Climate Strategies & EMS (Environmental Management System):

- Semi-annual review meetings, customer environmental feedback, and supplier training.
- Employee engagement through compliance training and Earth Day events.
